Schedule F, Part I, Line 2 - Our grants have been wire transferred to an account in Zambia owned by the Catholic Diocese of Chipata. There the funds are transferred into a subaccount for Chikwa projects. Since its inception, Bishop George Lungwu has provided official oversight of the financial and executive operations of Chikwa Parish. To monitor to use of grant funds, Rev Gunderson speaks frequently with Chikwa's pastor, Rev Wilfred Bwezani Phiri, in part to discuss the progression of its projects. In addition, Rev Gunderson has travelled many times to Zambia to observe the projects and potential projects we support, and to meet with Diocese representatives charged with oversight, often at his own expense. In recent years, FOCP has coordinated closely with World Vision, a larger US not-for-profit focused on building local infrastructure, primarily basic water and electricity. In 2025, Fr Gunderson and a volunteer Board member visited the area to celebrate the blessing of the new St Joseph rectory, home base for priests and pastoral associates serving the region; to visit projects in process; and to observe the substantial infrastructure development activities being undertaken in the region. Since 2024, FOCP has paid for Fr Wilfred's travel-related expenses to the US, where he provides in-person updates to donors and conducts several other fundraising events and outreaches.
