Its fundraising philosophy is based on the dignity of the human person and the preferential option for the poor -- two principles grounded in Catholic Social Teaching.

Warm water was provisioned to the childbirth and postnatal facility.

Schedule F, Part I, Line 2 - The great majority of our grant funds have been wire transferred to an account in Zambia owned by the Catholic Diocese of Chipata. Funds are transferred into a subaccount for Chikwa projects. Since its inception, Bishop George Lungwu provides official oversight of the financial and executive operations of Chikwa Parish. In rare instances, for example the recent purchase of a tipper truck used for project construction, funds are transferred directly to the vendor, but only after adequate customs and legal documentation have been obtained. To monitor the use of grant funds, Rev Gunderson speaks frequently with Chikwa's pastor, Rev Wilfred Bwezani Phiri, in part to discuss the progression the projects. Photos and videos are provided periodically to Rev Gunderson, the Friends of Chikwa Board members, and several times a year to contributors. In addition, Rev Gunderson has traveled several times to Zambia to observe the projects firsthand and to meet with Diocese representatives and representatives of larger US not-for-profit focused on building infrastructure in Zambia, including the Chikwa region. Rev Gunderson has traveled to the region at his personal expense, however in 2023 Friends of Chikwa Parish NFP paid for local-only travel expenses for Rev Gunderson and Rev Wilfred to tour and observe the projects our grants fund. These costs, totaling \$975, are reflected as management costs as they support our oversight of projects receiving grants. In early 2024, FOCP paid the airfare for Fr Wilfred to travel to the US for several weeks, where he provided in-person updates to donors and conducted several other fundraising events and outreaches.
